Dear First User,

In addition to the guarantee terms provided by the respective manufacturer of the individual components of a **PowerSet Maxi X.X – XXX-Xp** we confirm the following extension of product guarantees for the respective components mentioned below.

The guarantee is provided under the condition that the First User registers himself and the PowerSet Maxi within two weeks after the delivery of the PowerSet Maxi to the First User according to the invoice date ("Actual Delivery Date") and remains registered during the respective term of this guarantee. The guarantee is only valid if the registration has been successfully completed which will be confirmed in an automated e-mail and has been completed in due time.

In case this is not done in due time this guarantee is not applicable and only the guarantee terms of the respective manufacturer of the individual components of the **PowerSet Maxi** shall apply (if those terms were not placed at your disposal please contact your vendor or Solar Frontier Europe GmbH). To make a claim under this extension of guarantee an evidence of the date of initial operation is required by submitting the record of the first time the **PowerSet Maxi** is put in operation, signed by you and your installer.

1. Ten (10) year Product Guarantee for Modules

We herewith confirm that according to the applicable "End User Limited Product and Power Output Guarantee for Modules SF1XX" (version LPG_Module_E_151208) we provide a product guarantee of ten (10) years.

All other terms and conditions of the "First User Limited Product and Power Output Guarantee for Modules SF1XX" remain unchanged and unaffected by this letter.





2. Ten (10) year Product Guarantee for Combining Cables and Connectors

Furthermore we herewith confirm that we provide in extension to the product guarantee by HIS Renewables GmbH (letter "Terms of Guarantee" dated 13.04.2016) a guarantee of ten (10) years for combining cables and connectors. In case a guarantee claim falls under this extended guarantee term, the First User of the product can make any justified claim directly against Solar Frontier Europe GmbH.

All other terms and conditions of the letter "Terms of Guarantee" dated 13.04.2016 remain unchanged and unaffected by this letter.

3. Ten (10) year Product Guarantee for Inverters

Furthermore we confirm that in case a guarantee claim falls under the guarantee term "Kostal Service and warranty conditions" of PIKO inverters – version dated 05/2014, the First User of the product can make any justified claim directly against Solar Frontier Europe GmbH.

All other terms and conditions of the "Kostal Service and warranty conditions" of PIKO inverters – version dated 05/2014 remain unchanged and unaffected by this letter.

This extension of guarantee rights is applicable for all PowerSet Maxi of Solar Frontier Europe GmbH.
